### PRESIDENT'S PONDERINGS...



This month I'd like to bring you all up to speed with what the committee has been working on since the AGM in November last year, aside from the day-to-day running of the club that you are all familiar with.

One of the key projects in recent years has been to sort out the review of our financial accounts so that we can once again make grant applications. With the new reviewer now in place they successfully completed their first review of the 2024 accounts at the beginning of the year. One of the remits to the AGM was to set the end of financial year date one month earlier, so hopefully when presenting the end of year accounts to the AGM this year, and in future years, they will already have passed review.

Now that the accounts are all ship shape we have started to apply for grants to cover some of the other projects that have been queueing up. The most pressing of these is the resealing of the entire car park and driveway around the back of the building, including reinstating all markings and wheel stops.

There is also a need to repaint the long external wall of the clubrooms facing the carpark to avoid issues with weathertightness. Because of the specific type of cladding material a tailored approach is needed that should ensure the job doesn't need repeating for some time. Although the rest of the building will probably also need repainting in the not too distant future, it is only this wall that needs more urgent attention.

We are also looking to replace our aging 'fleet' of Bridgemates. The next iteration of Bridgemates will be available in the next few months after being on the horizon for several years now. Our current Bridgemates suffer from connectivity issues and artifacts on the screens so it is time to retire or re-home them. We did investigate changing to tablets but were put off by the hassle and potential fire risk of having to charge so many devices. Hugh and Di had a play with them at the Gold Coast Congress and found them to be very user friendly.

As part of Rebecca's appointment as Club Captain at the last AGM we promised to put measures in place to ensure she was kept in the loop about our daytime sessions which are our biggest sessions. Rebecca, Karyl and myself are meeting weekly prior to the Friday afternoon session just to chat about what's been going on during the week and we have found this is working very well. I am also attending Friday bridge on a routine basis, although some weeks I am busy taking the beginners group out the back.

As you're probably aware we are also having a post-play social session on the last Friday of each month where members are encouraged to bring snacks to share and the bar is open for those who wish to partake. This has proved very popular and it's great to see people having a drink and a laugh at the club. To support this we needed to extend our bar license. Initially we were going to apply for a full bar license but it quickly became clear this would be an expensive and onerous process with no guarantee we would get the numbers to make it worthwhile. We then discovered through further investigation that it was possible to apply for a second special license for up to 12 additional dates which we have done and so legally we're all squared away.

I hope you enjoyed this look behind the scenes of what we've been up to and some of the exciting things on the horizon! **Mike.**

# TIP OF THE MONTH #18 | Responder's "Double and Speak"



**Bidding:** North opens 1D, East overcalls 1S. What does South bid? (S)he has 6 pts, but cannot bid 1NT without a spade stopper, nor 2H with only 6 pts. A "Negative Double" here promises at least 4 hearts and at least 6 pts...although unusual with a 6 card suit, Double is correct. With 19 pts, North rebids 2NT. South can now bid 3H, knowing partner will expect less than 10pts and 6 hearts, and partner raises to 4H.

**Lead:** West has a choice of two good sequence leads, and chooses 10S, partner's bid suit (in truth, the only better lead is JC, which is most unlikely).

Play: Plan your play...clues...has the lead helped you? Think before you play...you have four potential losers... 3 clubs and a diamond.

- With the Clubs the way they are, you really don't want West on lead. Fortunately (s)he led a spade (a diamond or heart lead wouldn't change the play materially).
- You have a diamond loser, and may lose it to west (the danger hand)...how can you avoid that?

Duck the opening lead... East takes KS and plays 3S back (asking for a Club...no better defence).

On this second trick you throw a diamond loser from hand. Now play 2 rounds of trumps.

Then play AD, KD and ruff a diamond, if necessary with JH, making your diamonds good.

Now back to QH, taking out the last trump, and you have 2 good diamonds on which to throw you're your 3 losing clubs. An overtrick!

#### TIP OF THE MONTH (CONTINUED)

#### Lessons:

- The first lesson is the use of the negative double to show 4 hearts. Later (re)bidding hearts, a "Responder's Double and Speak" shows extra length and a weakish hand. With an excellent hand North bids to 4H.
- Yet again, we see the critical importance of **thinking first**, before playing to the first trick. Many would unthinkingly play the AS, and later inevitably lose a diamond trick and then 3 club tricks, going down 1.
- This hand shows very well the importance of avoiding the "danger hand" getting the lead, in this hand West. If East has the AC, and 3-5 of them, as is the case here, you cannot avoid losing 3 club tricks.
- 4. "Loser-on-loser" technique has many applications... in this hand we solve the problem of taking the risk West might win the third diamond trick and then lead clubs. This happens quite often, especially when you have 8 cards in a side suit, 5 in one hand and 3 in the other, and the A and K. Throwing the third card in the short hand on a loser in the other creates short age which can be trumped, setting up the rest of the suit. In this hand you always had a losing diamond... you just swapped it for a losing spade to East, who could not damage you with a club lead.

Our Beginners Lessons are progressing well... It will be some time before they join play on Wednesday evening however I believe it's always a great time to remind us of aspects of general play so we set a great example.

These are **regulations from the NZ Bridge Manual** regarding written bidding...

- **27.6** All calls must be made in neat, legible, hand writing. Where there is any doubt about what is written, players should seek verbal clarification.
- **27.7** The bidding sheet should be turned over after the opening leader's partner has played to the first trick. Law 20 gives him/her the right to demand a review of the bidding up to that point. The duty of turning over the bidding sheet is that of dummy but, if he/she omits to do so, all Players have the right to rectify his/her omission.
- **27.8** The laws as to inflections, changes of call and so on apply mutatis mutandis to written bidding.
- **27.9** Players are required to use the same designations each time they call and not to vary the way in which they make their bids. Full stops should not be used as a matter of practice.
